This is to provide notice to members of the Bar and the public that the Judicial Nominating Commission for the State of Georgia, created by an Executive Order of Governor Nathan Deal, is now engaged in the process of receiving names of persons to fill a vacancy on the State Court of Gwinnett County created by the appointment of the Honorable Randy Rich as Superior Court Judge of the Gwinnett Judicial Circuit, effective May 27, 2014. Applicants whose name appeared on the previous Gwinnett County short list will automatically be on the short list for this vacancy unless the applicant notifies the Judicial Nominating Commission of the withdrawal of their name for consideration.

Members of the bar may submit their own name or the names of others. The public is also invited to submit nominations. Such names should be sent to the Commission by June 13, 2014. (By letter addressed to Judicial Nominating Commission, c/o Dana McGuire, 600 Peachtree, N.E., Suite 5200, Atlanta, GA 30308-2216, by fax to 404-962-6919 or by email to [dana.mcguire@troutmansanders.com](mailto:dana.mcguire@troutmansanders.com)).

To each person nominated, the Commission will send an application package to be returned for receipt on or before June 27, 2014. Upon the receipt of all new applications, the Judicial Nominating Commission will schedule interviews of new applicants sometime after July 7, 2014, to the extent necessary. Applicants will be notified of the time for their interview. All interviews will be held at The State Bar of Georgia, 104 Marietta Street, Atlanta, GA 30303.

The Commission will select and recommend to the Governor from among those persons found to be "qualified" or "well qualified" a short list of up to five persons for this position.
