This is to provide notice to members of the Bar and the public that the Judicial Nominating Commission for the State of Georgia, established by Executive Order of Governor Brian P. Kemp, is now engaged in the process of receiving names of persons to fill a vacancy on the Court of Appeals of Georgia.

Anyone who submitted an application in response to the Judicial Nominating Commission's vacancy notice dated January 19, 2023, for the Court of Appeals is not required to submit a new application for this vacancy. Your prior application will be reconsidered for this vacancy. New applicants are still required to follow the nomination and application requirements below.

Members of the Bar and the general public are invited to submit nominations for this vacancy. Members of the Bar may submit their own name or the names of others. The public is also invited to submit names for nomination. Nominations must be received by the Commission no later than **October 20, 2023** and state the name of the person nominated, email of the nominee, and indicate that the nomination is for the Court of Appeals.
