An application package will also be emailed to each nominee who supplies an email address to the Commission. Applications must be returned to the Commission on or before <u>January 24, 2020</u>. The Commission will select and recommend to the Governor a short list of up to three persons from those applicants interviewed and found to be "qualified" or "well qualified" for this position.
