Nominations must be received by the Commission no later than **July 12, 2019**.

An application package will also be emailed to each nominee who supplies an email address to the Commission. Applications must be returned to the Commission on or before **July 26**, **2019**. The Commission will meet to interview applicants sometime after **July 29**, **2019**. Applicants selected for an interview will be notified of the date and time for their interview. All interviews will be held at The State Bar of Georgia, 104 Marietta Street, Atlanta, Georgia 30303.

The Commission will select and recommend to the Governor a short list of up to three persons from those applicants interviewed and found to be "qualified" or "well qualified" for this position.
